

International Exhibitors with Product in the U.S., but NOT in Nevada

Deadline for receipt of alcohol in wholesaler's warehouse is January 12, 2024

(Late fees will apply for product delivery between January 13 – 19, 2024. No product will be accepted after January 19.)

If your product exists in the United States, and has label approval, you may ship your product from your importer or U.S. based warehouse to one of the WSWA Nevada Wholesalers listed in the WSWA Alcohol Beverage Product Handling Guidelines who have agreed to clear product for Access LIVE.

If you are not currently working with an importer nor have label approval, you must contact Southern Glazer's Wine & Spirits and their customs broker to appropriately ship your product to Nevada for Access LIVE.

Please follow the steps below:

- 1** Read and follow the instructions in the WSWA Alcohol Beverage Product Handling Guidelines found on the Exhibitor Resources webpage or in the Freeman Exhibitor Services Kit.
- 2** International Exhibitors, not distributed in Nevada must use Southern Glazer's Wine & Spirits as their wholesaler for procession product for Access LIVE.
- 3** Complete all necessary forms by the deadline.
- 4** Pay all taxes and fees to the selected wholesaler and Certificate of Compliance (COC) to the state of Nevada. **Please note:** There is a \$50 fee that must be paid by check to the State of Nevada along with the Certificate of Compliance application. IF you do not have a US Checking account, please email Molly Fontaine, WSWA Director of Sales and Business Development at molly.fontaine@wswa.org.
- 5** Prepare your shipment using crush resistant packaging. WSWA, wholesalers and Freeman are not responsible for breakage.
- 6** Affix the appropriate destination labels on the SIDE of each case before shipping. Destination labels can be found in the Freeman Exhibitor Services Kit or on our [Exhibitor Resources webpage](#).
- 7** Ship your alcohol products to selected Nevada wholesaler. The wholesaler will arrange delivery to the venue and to Freeman.
- 8** Complete the Alcohol Beverage Product List. This list will be used to inventory and sort your shipment once it arrives in Las Vegas. Send completed list to Hanna Empen, Hanna@wswa.org.
